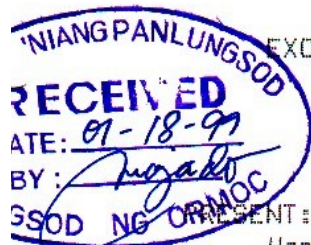

Kagawad Dennis Y. Capuyan; be it


RESOLVED, to pass a resolution TRANSFERRING THE REGULAR SESSION OF

ADOPTED, January 14, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
