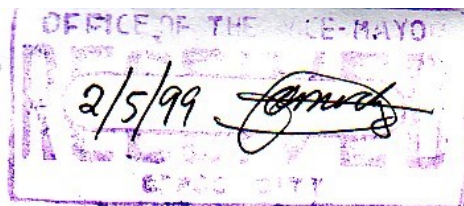
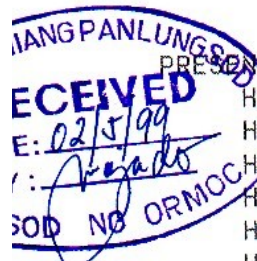

RESOLUTION NO. 99-14

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
AGAINST PROVISION FOR PRIOR YEAR'S OBLIGATION, A NON-
OFFICE ACCOUNT IN OUR 1999 ANNUAL BUDGET, THE AMOUNT OF
EIGHT HUNDRED SIXTY SEVEN THOUSAND PESOS (P867,000.00)
REPRESENTING UNPAID 1998 ELECTRIC BILLS OF ORWASA.

WHEREAS, this Sanggunian is in receipt of a communication dated
January 13, 1999 from Engr. Gervacio L. Germano, Jr., Waterworks
Superintendent II, addressed to the Honorable Sangguniang Panlungsod,
Ormoc City, thru the Hon. Alfredo F. Capahi, Chairman, Committee on
Finance, for an authority to charge his 1998 Electric Bills in the
amount of EIGHT HUNDRED SIXTY-SEVEN THOUSAND PESOS (P867,000.00) against
the account Prior Year's Obligation;

WHEREAS, the City Budget Officer through 3rd Indorsement dated
January 20, 1999 has recommended that authority be granted the City
Accountant to charge said request against Prior Year's Obligation, a
Non-Office Account under the 1999 Annual Budget;

WHEREAS, the OIC-City Treasurer's Office through 5th Indorsement
dated January 22, 1999 has stated that "fund is available to be sourced
from Provision for prior year's obligation, a non-office account subject
however to accounting and auditing rules and regulations;

NOW, THEREFORE, on motion of Councilor Alfredo F. Capahi, Chairman,
Committee on Finance, jointly seconded by Councilor Mariano Y. Corro and
Councilor Dennis Y. Capuyan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST PROVISION FOR PRIOR YEAR'S OBLIGATION, A NON-OFFICE ACCOUNT IN OUR 1999 ANNUAL BUDGET, THE AMOUNT OF EIGHT HUNDRED SIXTY SEVEN THOUSAND PESOS (P867,000.00) REPRESENTING UNPAID 1998 ELECTRIC BILLS OF ORWASA;
