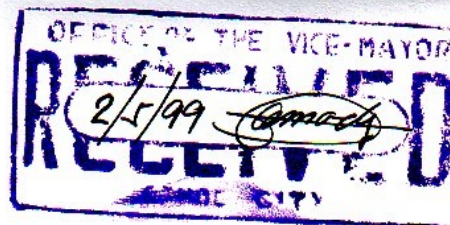

RESOLUTION NO. 99-16

A RESOLUTION STRONGLY AND FAVORABLY ENDORSING TO HIS
EXCELLENCY, PRESIDENT JOSEPH EJERCITO ESTRADA, THE
REQUEST OF THE SANGGUNIANG BARANGAY OF CAMP DOWNES,
ORMOC CITY, TO SEGREGATE A PORTION OF CAMP DOWNES
MILITARY RESERVATION OF NINE (9) HECTARES THEREOF, INTO
A RESIDENTIAL AREA, SO AS TO ESTABLISH A SEPARATE
TERRITORY FOR BARANGAY CAMP DOWNES AND LOTS THEREIN TO
BE SOLD ON INSTALLMENT BASIS TO ACTUAL RESIDENTS.

WHEREAS, this Sanggunian is in receipt of Resolution No. 01 s. 99
from the Barangay Council of Barangay Camp Downes, this city entitled,
"A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR HON. EUFROCINO M.
CODILLA, SR., THRU THE SANGGUNIANG PANLUNGSOD NG ORMOC TO ENDORSE THE
ATTACHED XEROX COPIES OF RESOLUTIONS OF BARANGAY CAMP DOWNES TO HIS
EXCELLENCY, PRESIDENT JOSEPH EJERCITO ESTRADA TO SEGREGATE A PORTION OF
CAMP DOWNES MILITARY RESERVATION OF NINE (9) HECTARES THEREOF, INTO A
RESIDENTIAL AREA, SO AS TO ESTABLISH A SEPARATE TERRITORY FOR BARANGAY
CAMP DOWNES AND LOTS THEREIN TO BE SOLD IN INSTALLMENT BASIS TO ACTUAL
RESIDENTS;"

WHEREAS, said request has been referred to Engr. Darlito Pareja of
the Tax Mapping Division, this city, who in turn, through 3rd
Indorsement dated 28 January 1999 has stated that:

Respectfully returned to Hon. Kagawad Alfredo F. Capahi, the herein request of Barangay Camp Downes, this city, "A Resolution requesting his Excellency, President Joseph Ejercito Estrada to segregate the portion of Camp Downes Military reservation of nine (9) hectares separating Barangay Camp Downes and the Military reservation;" with the following informations to wit:

1. The military area reservation is composed of several lots namely:

a, b, c, d, e, f, g, h, i, j, k, l, m, n, o and p;

2. These lots are not tied-up to B.L.L.M. or Bureau of Lands/Location Monuments under cadastral survey 256, since, the original survey was done on March 1 to 2 1912, by H.E. NEIBERT and American surveyor;
3. The cadastral surveyors just left the military area reservation by itself as it being previously occupied;
4. The said lot must be first tied-up to the cadastral monuments to conform its coordinates to cadastral survey in 1928-1935, before we could proceed to the delineation showing the actual occupants in the actual ground;
5. This is a comprehensive job that needs much time, which to our estimates three to four months without interruption.

We would like to inform the Barangay Camp Downes that our priority project now is the JICA Flood Control Mitigation Project, so that we could not devote most of our time in the said survey.

Nevertheless, we are also considering this job a priority, only it will cost us a little delay because of its voluminous computation to be made, and the intervening works that will come to our office.

CODILLA, S. R., THRU THE SANGGUNANG PANLUNGSOD NG ORMOC, TO ENDORSE THE ATTACHED PETITION OF THE BARANGAY CAMP DOWNES RESIDENTS' ASSOCIATION MOST RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, TO SEGREGATE AND RECLASSIFY A PORTION OF CAMP DOWNES MILITARY RESERVATION, SPECIFICALLY NINE (9) HECTARES THEREOF, INTO A RESIDENTIAL AREA SO AS TO

ESTABLISH SEPARATE TERRITORY FOR BARANGAY CAMP DOWNES AND LOTS THEREIN TO BE AWARDED TO ACTUAL RESIDENT", WHICH WAS ENDORSED TO THAT OFFICE FOR APPROPRIATE ACTION;"

WHEREAS, for a very long time now, these petitioning residents of Barangay Camp Downes, this city have been occupying said portion of the military reservation and have been raising their families thereat which can be rightfully presumed that said portion is no longer needed by the military authorities and as such, same be released to the present occupants or actual residents who are mostly military servicemen, war veterans and former military servicemen, for them to be considered as rightful owners of the lots they are presently occupying;

WHEREFORE, on motion of Councilor Alfredo F. Capahi, Councilor-In-Charge, jointly seconded by Councilors Sotero M. Pepito and Chiqui B. Labagala; be it




