


RESOLUTION NO. 99-23

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF SEVEN THOUSAND SEVEN HUNDRED FORTY-NINE PESOS & 99/100, (P7,749.99), AGAINST PROVISION FOR PRIOR-YEAR'S OBLIGATION, A NON-OFFICE ACCOUNT IN THE 1999 ANNUAL BUDGET, FOR PAYMENT OF THE FOLLOWING CLAIMS: A) PERA (MR. JESUS F. CAPAHI, FOR DEC. 1997 TO DEC. 1998) - P6,500.00; AND B) SALARY (MR. MANUEL P. PACA, JR., FOR DEC. 16-21, 1998) - P1,249.99.

WHEREAS, this Sangguniang Panlungsod is in receipt of a letter from Jesus F. Capahi, Assistant City Treasurer, Officer-In-Charge, dated January 26, 1999 addressed to the Honorable Members, Sangguniang Panlungsod, Ormoc City, requesting for a resolution granting authority of the City Accountant to charge against Prior Years Obligation for payment of his PERA from December 1997 up to December 1998 in the amount of P6,500.00 and salary of Manuel P. Paca, Jr. for the period December 16-21, 1998 in the amount of P1,249.99 for a total of P7,749.99;

WHEREAS, the City Legal Officer through 4th Indorsement dated 5 February 1999 has stated that:

Respectfully returned to the Secretary to the City Mayor, Ruviniue E. Mendola, his 3rd Indorsement with the amount that the PERA of OIC-City Treasurer from December 1997 to December 1998 in the amount of P6,500.00 may be charged against Prior Year's Obligation.

As regards the salary of Mr. Manuel P. Paca, Jr. for December 16-21, 1998 in the amount of ₱1,249.99 the same may likewise be charged against Prior Year's Obligations considering that he has already fully restituted the amount of his collection shortage. Hence, a resolution from the Honorable Sangguniang Panlungsod granting authority to the City Accountant for this purpose is in order.

JESUS F. CAPAHI, FOR DEC. 1997 TO DEC. 1998) - ₱6,500.00; AND B) SALARY (MR. MANUEL P. PACA, JR., FOR DEC. 16-21, 1998) - ₱1,249.99;
