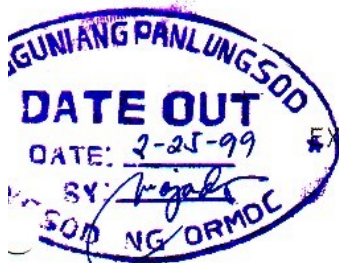
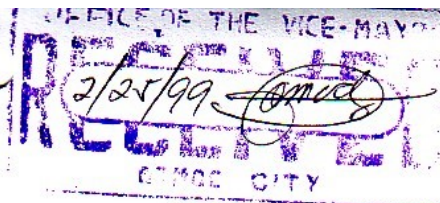

RESOLUTION NO. 99-27

A RESOLUTION INTERPOSING NO OBJECTION AND GRANTING SOCIAL  
ACCEPTABILITY TO THE POULTRY OF ASPRAC AGRICULTURAL  
CORPORATION, AS REQUESTED BY ITS VICE-PRESIDENT EDUARDO  
C. PONGOS IN CONNECTION WITH THEIR APPLICATION FOR ECC.

WHEREAS, this Sanggunian is in receipt of a letter dated 5 February  
1999 from Mr. Eduardo C. Pongos, Vice President, ASPRAC Agricultural  
Corporation addressed the Honorable Jose C. Alfaro requesting a City  
Resolution interposing no objection to the said poultry project situated  
at Brgy. Camp Downes, Ormoc City;

WHEREAS, said agricultural corporation through its Vice President  
has applied for the issuance of an Environmental Compliance Certificate  
(ECC) with the Department of Environment and Natural Resources (DENR)  
relative to its application for the operation of a poultry farm in said  
place;

WHEREAS, upon proper consultation with the residents of Barangay  
Camp Downes, this city, said project is socially accepted as manifested  
by the Barangay Council of said barangay through a resolution dated 20  
December 1997, Barangay Resolution No. 97-34 entitled, "A RESOLUTION  
FAVORABLY ENDORSING THE APPLICATION OF ASPRAC AGRICULTURAL CORPORATION,  
THROUGH MR. RODOLFO C. PONGOS, FOR A FIVE THOUSAND HEADS POULTRY  
PROJECT, PROVIDED THAT ALL THE REQUIREMENTS AND PROPER ENVIRONMENTAL  
PRACTICES IN ITS OPERATION ARE ADHERED TO; AND PROVIDED FURTHER THAT  
STRICT COMPLIANCE WITH THE DENR ENVIRONMENTAL COMPLIANCE CERTIFICATE  
(ECC) IS FOLLOWED";

WHEREFORE, foregoing premises considered, on motion of Councilor  
Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources and  
Environmental Control, severally seconded by Councilors Mariano Y.  
Corro, Alfredo F. Capahi and Eduardo P. Tan; be it



RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INTERPOSING NO OBJECTION AND GRANTING SOCIAL ACCEPTABILITY TO THE POULTRY OF ASPRAC AGRICULTURAL CORPORATION, AS REQUESTED BY ITS VICE-PRESIDENT EDUARDO C. PONGOS IN CONNECTION WITH THEIR APPLICATION FOR ECC;
