AUTHORIZING THE CITY ACCOUNTANT TO CHARGE RESOLUTION THUOMA OF SIX THOUSAND ONE HUNDRED EIGHTY PESOS AGAINST THE ACCOUNT-PROVISION FOR PRIOR (P6,180,00) OBLIGATION, A NON-OFFICE ACCOUNT IN THE 1999 YEAR'S ANNUAL EUDGET, FOR PAYMENT OF UNPAID LONG DISTANCE CALLS OF THE FOLLOWING OFFICES:

WHEREAS, this Sanggunian is in receipt of a letter dated February 3, 1999 from the Office of the City Mayor Eufrocino M.
