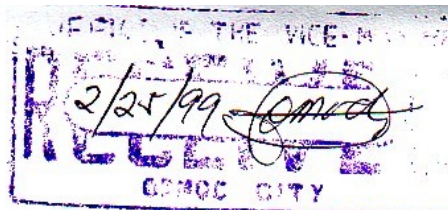

FEBRUARY 28, 1999 TO MARCH 31, 1999;



President, OFRA, -all in Ormoc City;


