## RESOLUTION NO. 99-32

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCING M. CODILLA, SR , TO SIGN, FOR AND IN BEHALF EUFROCING M. CODILLA, SR, TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A DEED OF DONATION IN FAVOR OF THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS (DECS), REPRESENTED BY ITS ASSISTANT SCHOOLS DIVISION SUPERINTENDENT SOLEDAD B. ACIDRE, OVER A PARCEL OF LAND, LOT 5111-PART OF THE SUBDIVISION PLAN, SITUATED AT BARANGAY LINAO, ORMOC CITY COVERING AN AREA TEN THOUSAND (10,000) SQ. METERS, PROVIDED, THAT A PROVISION SHALL BE INCORPORATED IN THE DEED DONATION, THAT IN THE EVENT THAT THE PROPERTY DONATED WILL NO LONGER BE USED BY THE DECS, OWNERSHIP THEREOF SHALL REVERT TO THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 23 Feb. 1999 from the Hon. City Mayor Eufrocino M. Codilla, Sr., requesting for the passage of a resolution authorizing him to sign the Deed of Donation of Land Lot 5111-part of the subdivision plan situated at Brgy. Linao, this city covering an area of Ten Thousand (10,000) sq. meters in favor of the Department of Education, Culture & Sports;

WHEREAS, said Lot 5111-part is to be used as a school site in compliance with the DECS policy of constructing buildings in donated to the said Department (DECS);

WHEREAS, the Asst. City Assessor, Engr. Darlito A. Pareja, through a CERTIFICATION dated 1 March 1999 has certified that Lot No. 5111 with an area of Twenty Five Thousand Five Hundred Thirty Two (25,532) sq. meters, with Tax Declaration No. 00048-00201 with a proposed area of one (1) hectare to be given to the Department of Education, Culture and · Sports (DECS) is a City Government lot per records available from said Office:

WHEREAS, the Barangay Council of Barangay Linao, this city in its desire to have a barangay high school site, passed Barangay Resolution No. 95-20 dated September 23, 1995 entitled, "A RESOLUTION EARNESTLY REQUESTING THE HONORABLE CITY MAYOR, TO DONATE TO THE DEPT. OF EDUCATION, CULTURE AND SPORTS (DECS), ONE (1) HECTARE PORTION OF THE LOT LOCATED AT BARANGAY LINAO, ORMOC CITY, TO SERVE AS BARANGAY HIGH SCHOOL SITE" and Barangay Resolution No. 95-28 dated November 25, 1995 entitled, "A RESOLUTION EARNESTLY REQUESTING THE 7TH SANGGUNIANG PANLUNGSOD NG ORMOC TO GIVE THE HON. CITY MAYOR EUFROCINO CODILLA, SR., THE AUTHORITY TO DONATE ONE HECTARE OF LAND FOR USE AS BARANGAY HIGH SCHOOL SITE IN BARANGAY LINAO, THIS AFOREMENTIONED LAND IS STILL OWNED BY THE CITY GOVERNMENT AND NOW PRESENTLY USE AS SCHOOL SITE BY THE DECS";

WHEREAS, this august Body has considered said request reasonable, hence, be accorded with due course of action;

WHEREFORE, foregoing premises considered on motion of Councilor Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by Councilors Dennis Y. Capuyan, Chiqui B. Labagala, Jose S. Serafica and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF DRIVOC, A DEED OF DONATION IN FAVOR OF THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS (DECS), REPRESENTED BY ITS ASSISTANT SCHOOLS DIVISION SUPERINTENDENT SOLEDAD B. ACIDRE, OVER A PARCEL OF LAND, LOT 5111-PART OF THE SUBDIVISION PLAN, SITUATED AT BARANGAY LINAO, ORMOC CITY COVERING AN AREA OF TEN THOUSAND (10,000) SQ. METERS, PROVIDED, THAT A PROVISION SHALL BE INCORPORATED IN THE DEED OF DONATION, THAT IN THE EVENT THAT THE PROPERTY DONATED WILL NO LONGER BE USED BY THE DECS, OWNERSHIP THEREOF SHALL REVERT TO THE CITY GOVERNMENT OF DRIVOC;
