A RESOLUTION AFFIRMING THE VALIDITY OF TAX ORDINANCE NO. 001-92 OF THE BARANGAY COUNCIL OF NAUNGAN, UNDER REVIEW. EXCEPT THE SECOND SENTENCE OF SECTION 2 (C). SUBSECTION (%) WHICH READS, . . . X X X "HOWEVER, THIS DOES NOT APPLY TO OWNERS OF FISHING BOATS WITH OR ATTHOUT ENGINES WHO ARE RESIDENTS OF BARANGAY NAUNGAN, THIS CITY, WHICH VIOLATES THE CONSTITUTIONAL PROVISION IN "EQUAL PROTECTION OF THE LAW" AND THUS THIS LEVEL HEREBY ENJOINS THE SANGGUNIANG BARANGAY OF NAUNGAN THE ECESSARY AMENDMENT THEREOF BY DELETING THE PROVISION.

WHEREAS, this Sanggunian is in receipt of Barangay Tax Ordinance No. 001-99 of the Barangay Council of Naungan, this city entitled, "AN ORDINANCE AMENDING SECTIONS 2 C, 4(a) AND (b) AND 5 OF TAX ORDINANCE NO. 001-93 DATED SEPTEMBER 12, 1993 OTHERWISE KNOWN AS AN ORDINANCE IMPOSING TAXES ON RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVELEGE PANEL, AND OTHER OUTDOOR ADVERTISEMENTS";
