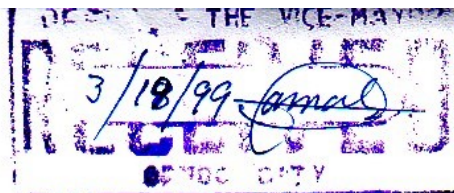

RESOLUTION NO. 99-36

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONOR, A DEED OF DONATION IN FAVOR OF THE DEPARTMENT OF EDUCATION, CULTURE & SPORTS (DECS), AS DONEE, REPRESENTED THEREIN BY ASSISTANT SCHOOLS DIVISION SUPERINTENDENT, MS. SOLEDAD S. ACIDRE, INVOLVING TWO (2) PARCELS OF LAND, LOT 7324-B, CONTAINING AN AREA OF EIGHT THOUSAND THREE HUNDRED SIXTY FIVE (8,365) SQUARE METERS AND LOT 7325-B, CONTAINING AN AREA OF TEN THOUSAND FOUR HUNDRED TWENTY SEVEN (10,427) SQUARE METERS, TO BE USED AS SECONDARY SCHOOL SITE AND ELEMENTARY SCHOOL SITE, RESPECTIVELY, BOTH SITUATED AT BARANGAY DOLORES, ORMOC CITY PROVIDED, THAT A PROVISIO SHALL BE INCORPORATED THEREIN THAT IF THE DONATED LOTS WILL NO LONGER BE USED FOR THE PURPOSE FOR WHICH THEY ARE DONATED, OWNERSHIP THEREOF SHALL IP SO FACTO REVERT TO THE CITY GOVERNMENT OF ORMOC, PROVIDED FURTHER, THAT THE CONSTRUCTION OF THE SCHOOL BUILDING AND ITS UTILIZATION OF ELEMENTARY AND SECONDARY SCHOOL SITES BE STARTED WITHIN THE PERIOD OF TWO (2) YEARS FROM THE DATE OF THE DONATION.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 25 February 1999 from the Hon. City Mayor Eufrocino M. Codilla, Sr., requesting for the passage of a resolution authorizing him to sign the Deed of Donation between the City Government of Ormoc, as donor and the Department of Education, Culture and Sports, as donee involving adjacent Lots 7324-B with an area of EIGHT THOUSAND THREE HUNDRED SIXTY FIVE (8,365) square meters and 7325-B with an area of TEN THOUSAND FOUR HUNDRED TWENTY SEVEN (10,427) square meters situated at Brgy. Dolores, Ormoc City;



WHEREAS, said adjacent lots 7324-B and 7325-B will be used as site for the construction of a Secondary School and Elementary School respectively as stated in a letter from the Assistant School Division Superintendent dated 1 February 1999 and clarified by the Honorable City Mayor Eufrocino M. Codilla, Sr., through 4th Indorsement dated 12 March 1999;

WHEREAS, the Barangay Council of Barangay Dolores, this city, in support to the said donation, passed Barangay Resolution No. 15 s. 1999 dated 2 January 1999 entitled, "A RESOLUTION SUPPORTING THE DECS SCHOOL ADMINISTRATORS OF THE DIVISION OF ORMOC CITY ON THE REQUEST TO THE SANGGUNANG PANLUNGSOD THROUGH THE CITY MAYOR, HON. EUFROCINO M. CODILLA, SR., TO TRANSFER THE NAME OF THE CERTIFICATE OF TITLE OF SCHOOL SITES OF THE SCHOOLS OF DOLORES PARTICULARLY ON CADASTRAL LOT NO. 7325-B AND 7324 FROM THE CITY GOVERNMENT TO THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS (DECS)";

WHEREAS, this august Body has considered said request reasonable, hence, be accorded with due course of action;

WHEREFORE, foregoing premises considered on motion of Councilor Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by Councilors Sotero M. Pepito and Alfredo F. Capahis; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONOR, A DEED OF DONATION IN FAVOR OF THE DEPARTMENT OF EDUCATION, CULTURE & SPORTS (DECS), AS DONEE, REPRESENTED THEREIN BY ASSISTANT SCHOOLS DIVISION SUPERINTENDENT, MS. ADOPTED, March 18, 1999.

RESOLVED, FURTHER, to furnish copies of this resolution each to the Honorable Secretary, Department of Education, Culture and Sports; the Honorable City Mayor of Ormoc, Eufrocino M. Codilla, Sr., the Regional Director, DECS, Region VIII, Tacloban City, the City Legal Officer, the City Administrator, the Asst. Schools Division Superintendent of Ormoc and others concerned, -in Ormoc City;
