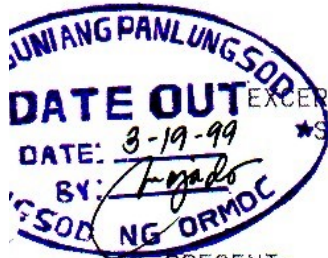

Committee on Finance duly seconded by Councilor Sotero M. Pepito; be it


RESOLVED, to pass a resolution APPROVING THE 1998 SUPPLEMENTAL

ADOPTED, March 18, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
