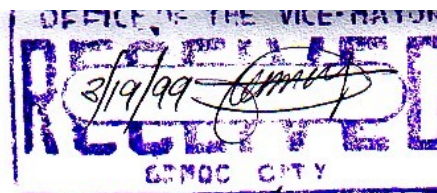
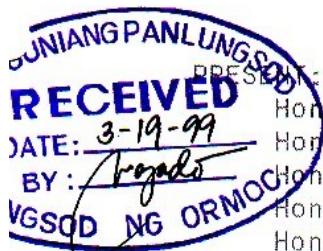

RESOLUTION NO. 99-40

A RESOLUTION APPROVING THE PROPOSED EVALUATION ACTIVITY
OF ALL THE AGRICULTURE PROJECTS IMPLEMENTED IN THE CITY
OF ORMOC BY AGRICULTURAL TRAINING INSTITUTE (ATI),
VISAYAS STATE COLLEGE OF AGRICULTURE (VISCA) AND THE
DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT 8 (DA-
RFU8).

WHEREAS, this Sanggunian is in receipt of CAFC Resolution No. 01 s.
1999 entitled, "A RESOLUTION ADDRESSED TO THE CITY MAYOR HON. EUFROCINO
M. CODILLA, SR., REQUESTING FOR APPROVAL TO CONDUCT AN EVALUATION OF ALL
THE AGRICULTURE PROJECTS IMPLEMENTED IN THE CITY OF ORMOC UNDER THE CITY
AGRICULTURAL SERVICES OFFICE AND CITY VETERINARY SERVICES OFFICE";

WHEREAS, said resolution mentions of the City Agriculture and
Fisheries Council's (CAFC) proposal for an evaluation of the
agricultural services delivery system of Ormoc in order to establish
benchmark information on the status of agricultural development in the
city in preparation for the Agriculture and Fisheries Modernization Act
(AFMA) implementation wherein evaluation findings can guide the city in
strengthening its agriculture sector which comprises 61 per cent of the
city's economy;
