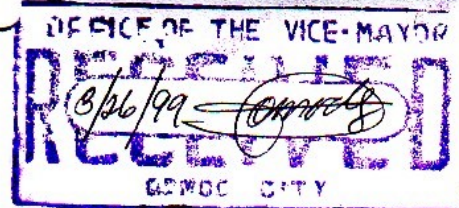
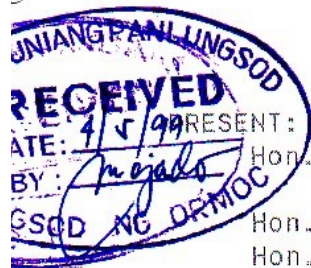

REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE

WHEREAS, this Sanggunian is in receipt of Resolution No. 01 s. 1999  
from the City Development Council, entitled: "A RESOLUTION APPROVING THE


