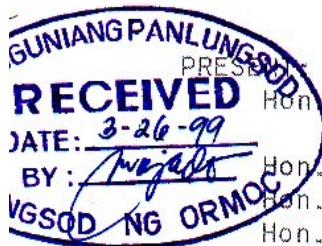

Thursday;


WHEREFORE, foregoing premises considered, on motion of Councilor
