

RESOLUTION NO. 99-48

A RESOLUTION RETURNING BARANGAY TAX ORDINANCE NO. 001 S.  
1999 TO THE BARANGAY COUNCIL OF PUNTA FOR THEIR  
APPROPRIATE ACTION.

WHEREAS, this Sanggunian is in receipt of Tax Ordinance No. 001 S. 1999 from the Barangay Council of Barangay Punta, this city, entitled: "AN ORDINANCE IMPOSING TAXES ON RETAILERS BILLBOARDS, BARANGAY CLEARANCES, AND BARANGAY PERMITS";

WHEREAS, the Sangguniang Panlungsod ng Ormoc is, by law granted the Power of Review as to whether said ordinance is consistent with law and city ordinances (Sec. 57, 1991, LGC);

WHEREAS, it is the observation of this august Body that said ordinance is technically defective, hence, same be returned to the barangay of origin for them to make the necessary corrections in conformity with the requirements of the law;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, jointly seconded by Eduardo P. Tan and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RETURNING BARANGAY TAX ORDINANCE NO. 001 S. 1999 TO THE BARANGAY COUNCIL OF PUNTA FOR THEIR APPROPRIATE ACTION;
