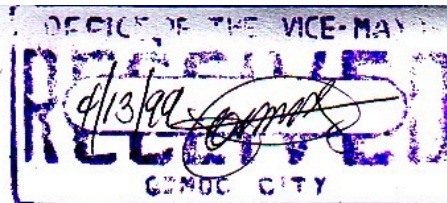
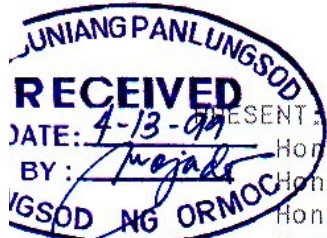

THE 1999 ANNUAL BUDGETS OF THE FOLLOWING BARANGAYS IN ORMOC CITY:




