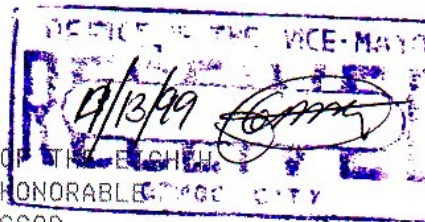
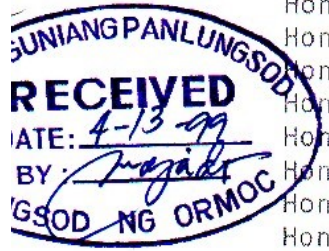

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN
A MEMORANDUM OF AGREEMENT WITH THE OTHER CONCERN
PARTIES; NIA, PNOC-EDC & ISAGANI BANEZ, ON THE PROPOSED
ISIP-II ENVIRONMENTAL IMPROVEMENTS IN THE UPPER
WATERSHEDS OF BAO RIVER.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 01
February 1999 from Mr. Antonio A. Vizcarra, OIC, Irrigation
Superintendent, National Irrigation Administration of the Letter of Mr.
Alexander A. Reuyan, Regional Manager, NIA, together with a copy of the
Memorandum of Agreement which is the main subject of said communication;

WHEREAS, the said MOA mentions of the establishment of two (2)
Pilot areas of about 10 hectare size to implement soil erosion control
program within the watershed of the Bao River Irrigation System which is
to be participated in by LGU's concerned;

WHEREAS, the City Legal Officer through 3rd Indorsement dated 11
February 1999 has stated that "the signing of the attached MOA by all
the parties concerned will redound to the benefit of Leyte and its
residents";
