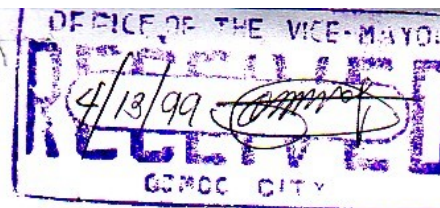

THE OCCASSION OF HIS BIRTHDAY ON APRIL 19, 1999;


