

RESOLUTION NO. 99-63

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
AGAINST CURRENT APPROPRIATION FOR LAW MAGAZINES &
PERIODICALS OF THE MUNICIPAL TRIAL COURT IN CITIES, THE
AMOUNT OF FOUR THOUSAND FOUR HUNDRED PESOS (P4,400.00)
FOR PAYMENT OF NEWSPAPER SUBSCRIPTIONS FOR THE PERIOD
MAY 1998 TO DECEMBER 1998.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 30
March 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr., of
the request of Mrs. Luisa C. Penserga, Clerk of Court IV Municipal Trial
Court in Cities, 8th Judicial Region, Ormoc City for an appropriation in
the amount of P4,400.00 to cover payment for newspaper subscriptions of
the Municipal Trial Court in Cities for the period May 1998 to December
1998;

WHEREAS, the City Budget Officer through 4th Indorsement dated 16
April 1999 has recommended that authority be granted to the City
Accountant to charge said obligation against current appropriation - Law
Magazines & Periodicals of said Office;

WHEREAS, the Officer-In-Charge City Treasurer's Office through 6th
Indorsement date 20 April 1999 has stated that fund is available subject
however to accounting and auditing rules and procedures;
