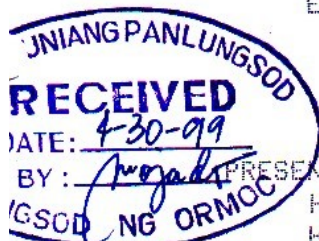

RESOLUTION NO. 99-66

A RESOLUTION APPROVING ORDINANCE NO. 99-02 SERIES OF 1999
OF THE SANGGUNIANG BARANGAY OF LINAO, THIS CITY,
ENTITLED: "AN ORDINANCE IMPOSING THE INCREASE OF
BARANGAY CLEARANCE FEE ON BUSINESS ESTABLISHMENT,
EMPLOYMENT, TRAVEL ABROAD, MARRIAGES, ENROLMENT AND
CHARACTER VERIFICATION IN THE BARANGAY".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 99-02
series of 1999 of the Barangay Council of Linao, this city, entitled:
"AN ORDINANCE IMPOSING THE INCREASE OF BARANGAY CLEARANCE FEE ON
BUSINESS ESTABLISHMENT, EMPLOYMENT, TRAVEL ABROAD, MARRIAGES, ENROLMENT
AND CHARACTER VERIFICATION IN THE BARANGAY";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City), is by law, granted the Power of
