A RESOLUTION APPROVING ORDINANCE NO. 99-02 SERIES OF 1999 OF THE SANGGUNIANG BARANGAY OF LINAO, THIS CITY, "AN ORDINANCE IMPOSING THE INCREASE CLEARANCE FEE ON BUSINESS ESTABLISHMENT, T TRAVEL ABROAD, MARRIAGES, ENROLMENT AND EMPLOYNENT. CHARACTER VERIFICATION IN THE BARANGAY".

this Sanggunian is in receipt of Ordinance No. 99-02 of the Barangay Council of Linao, this city, entitled: WHEREAS, series of 1999 of AN ORDINANCE IMPOSING THE INCREASE OF BARANGAY CLEARANCE FEE ON RUSINESS ESTAPLISHMENT, EMPLOYMENT, TRAVEL ABROAD, MARRIAGES, ENROLMENT AND CHARACTER VERIFICATION IN THE BARANGAY";
