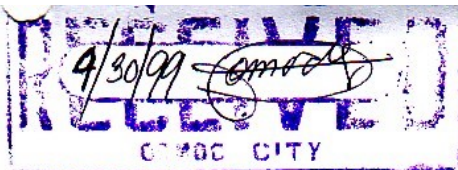
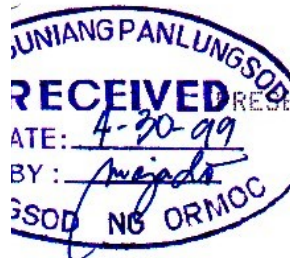

RESOLUTION NO. 99-67

A RESOLUTION APPROVING ORDINANCE NO. 99-001 OF THE  
SANGGUNIANG BARANGAY OF LICUMA, THIS CITY, ENTITLED:  
"AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS,  
BILLBOARDS, SIGNBOARDS, PRIVILEGE PANEL, AND OUTDOOR  
ADVERTISEMENTS, BARANGAY CLEARANCE, BARANGAY PERMIT,  
MARRIAGE CLEARANCE, AND OTHER CLEARANCE CERTIFICATION".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 99-001 of  
the Barangay Council of Licuma, this city, entitled: "AN ORDINANCE  
IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVILEGE  
PANEL, AND OUTDOOR ADVERTISEMENTS, BARANGAY CLEARANCE, BARANGAY PERMIT,  
MARRIAGE CLEARANCE, AND OTHER CLEARANCE CERTIFICATION";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City), is by law, granted the Power of  
Review as to whether the said ordinance is consistent with law and city  
X X X ordinances; (Sec. 57, 1991, LGC)

WHEREAS, it is the observation of this august Body, through the  
representation of the Honorable Chairman, Committee on Laws and  
Ordinances that the aforesaid ordinance has conformed to pertinent  
provisions of the Local Government Code, hence, reasonable and within  
the province of the Sangguniang Barangay of Brgy. Licuma, to legislate;

WHEREFORE, foregoing premises considered, on motion of Councilor  
Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances,  
severally seconded by Councilors Chiqui B. Labagala, Dennis Y. Capuyan,  
Claudio P. Larrazabal and Jose S. Serafica; be it

RESOLVED, to pass a resolution APPROVING ORDINANCE NO. 99-001 OF  
THE SANGGUNIANG BARANGAY OF LICUMA, THIS CITY, ENTITLED: "AN ORDINANCE  
IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVILEGE

MARRIAGE CLEARANCE, AND OTHER CLEARANCE CERTIFICATION";
