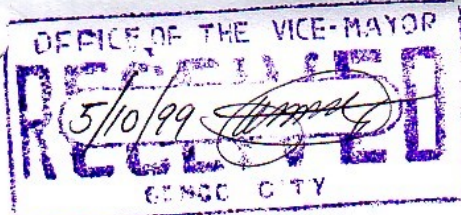



ADOPTED, May 06, 1999.


