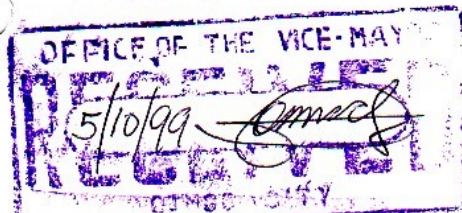

RESOLUTION NO. 99-70

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00) AGAINST CURRENT APPROPRIATION FOR YOUTH DEVELOPMENT PROGRAM OF THE CITY MAYOR'S OFFICE, TO DEFRAY FOR THE EXPENSES TO BE INCURRED IN HOSTING THE 9TH REGIONAL SKILLS COMPETITION WHICH WILL BE HELD IN ORMOC CITY.

PRESENTED for consideration by this august Body is 1st Indorsement of the Honorable City Mayor Eufrocino M. Codilla, Sr., dated 17 March, 1999, forwarding to Honorable Celso P. Adolfo, Vice Mayor and Presiding Officer, the request of August A. Capio, Regional Director, Technical Education and Skills Development Authority (TESDA), Region VIII, for an appropriation in the amount of ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) to defray expenses for food and other expenses and another FIFTY THOUSAND PESOS (P50,000.00) for miscellaneous expenses to be incurred during the 9th Regional Skills Competition (RSD) which will be held in Ormoc City tentatively on May 3, 1999;

WHEREAS, the City Budget Officer, Mrs. Elena S. Aviles, through 4th Indorsement dated April 20, 1999 has stated that above request be sourced from the Office of the City Mayor's current appropriation for Youth Development Program;

The Honorable City Mayor through 6th Indorsement dated May 3, 1999, requested this august Body for the approval of the said appropriation to be used not only for the Youth of Ormoc City but of Region VIII and that said request is URGENT as stated in a separate letter of the Hon. City Mayor dated 03 May 1999.


