


RESOLUTION NO. 99-71

A RESOLUTION APPROVING THE APPLICATION FOR DEVELOPMENT PERMIT OF ORMOC MEMORIAL GARDENS OWNED BY ATTORNEY BENJAMIN T. PONGOS, SR., AND MR AUGUSTO T. PONGOS LOCATED AT BARANGAY CAMP DOWNES, ORMOC CITY COMPRISING LOT NOS. 1592-A, 1592-1-2, 1592-B-4 AND 1584-A HAVING A TOTAL PROJECT AREA OF 82,088 SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. 31151, 31153, 4758 AND 4767 CONTAINING SIXTEEN THOUSAND FIVE HUNDRED EIGHTY FIVE (16,585) PLOTS.

PRESENTED, for consideration by this august Body is the following:

An Application for Development Permit of Ormoc Memorial Gardens with Preliminary Approval and Locational Clearance of Memorial Park No. 023-93 per S.P. Resolution No. 98-102 S. 1998 dated 3 December 1998 comprising lot nos. 1592-A, 1592-1-2, 1592-B-4 and 1584-A having a total project area of 82,088 square meters covered by Transfer Certificate of Title Nos. 31151, 31153, 4758 and 4767 owned by Atty. Benjamin T. Pongos, Sr., and Mr. Augusto T. Pongos located at Brgy. Camp Downes, Ormoc City containing 16,585 plots;

WHEREAS, this august Body has found out the said application to be in order with the site of the proposed project inspected and the documents and other papers have shown that said project is within the areas classified as PARKS AND OPEN SPACES CEMETERY USES pursuant to the Approved Zoning Ordinance #14 series of 1978, NCC, Human Settlements Regulatory Commission, now Housing and Land Use Regulatory Board (HLURB) and is "in accordance with the provision of HLURB A.O. No. 07 series of 1998 dated September 20m 1988, Amendments to Rules and Regulations for Memorial, E.O. 648 and R.A. 7160 and its implementing rules and regulations";

WHEREFORE, foregoing premises considered, on motion of Councilor Jose S. Serafica, Chairman, Committee on Zoning and Urban Development jointly seconded by Councilors Mariano Y. Corro and Dennis Y. Capuyan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the APPLICATION FOR DEVELOPMENT PERMIT OF ORMOC MEMORIAL GARDENS OWNED BY ATTORNEY BENJAMIN T. PONGOS, SR., AND MR AUGUSTO T. PONGOS LOCATED AT BARANGAY CAMP DOWNES, ORMOC CITY COMPRISING LOT NOS. 1592-A, 1592-1-2, 1592-B-4 AND 1584-A HAVING A TOTAL PROJECT AREA OF 82,088 SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. 31151, 31153, 4758 AND 4767 CONTAINING SIXTEEN THOUSAND FIVE HUNDRED EIGHTY FIVE (16,585) PLOTS;
