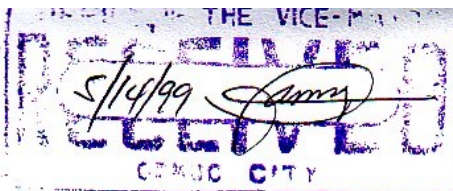
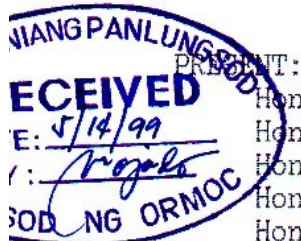

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE - BUREAU OF FISHERIES AND AQUATIC RESOURCES, FISHERIES REGIONAL OFFICE NO. VIII, REPRESENTED BY ITS DIRECTOR JOSE S. GARNIDO, JR., WITH OFFICE ADDRESS AT KANHURAW HILL, TACLOBAN CITY, FOR IMPLEMENTATION OF THE FISHERIES RESOURCE MANAGEMENT PROJECT (FRMP).

WHEREAS, this Sanggunian is in receipt of 3rd Indorsement dated 15 April 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for the passage of a resolution authorizing him to sign for and in behalf of the City of Ormoc a Memorandum of Agreement (MOA) between the Department of Agriculture - Bureau of Fisheries and Aquatic Resources and the City of Ormoc;

WHEREAS, Said Memorandum of Agreement mentions of the implementation of the Fisheries Resource Management Project (FRMP);
