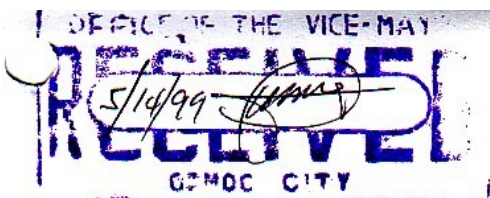


ADOPTED, May 13, 1999.


