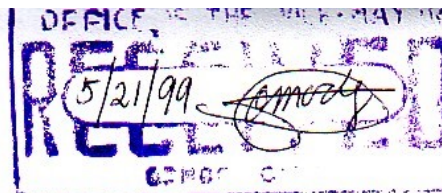
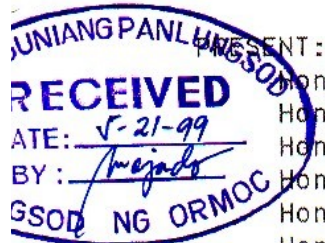

ADOPTED, May 20, 1999.


