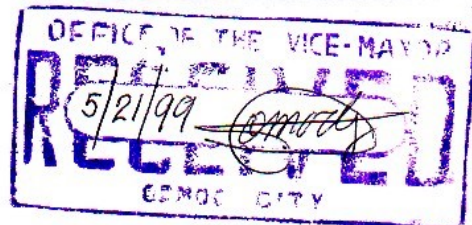
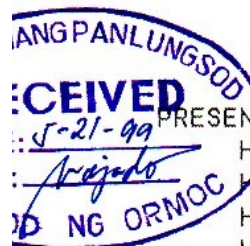

RESOLUTION NO. 99-77

A RESOLUTION PARTIALLY REORGANIZING THE CHAIRMANSHIP AND MEMBERSHIP OF THE STANDING COMMITTEES OF THE EIGHT SANGGUNIANG PANLUNGSOD NG ORMOC, AND THE ASSIGNMENT OF THE KAGAWAD-IN-CHARGE ON THE EIGHT BARANGAYS, IN VIEW OF THE UNTIMELY DEMISE OF COUNCILOR BENJAMIN B. LLADOC, THEREBY AMENDING ACCORDINGLY RESOLUTION NO. 98-06 RE: ORGANIZATION OF STANDING COMMITTEES, ETC.

WHEREAS, this Sanggunian on July 9, 1998, passed Resolution No. 98-06, entitled: "A RESOLUTION ORGANIZING THE STANDING COMMITTEES OF THE EIGHT SANGGUNIANG PANLUNGSOD NG ORMOC AND FURTHER, REAPPORTIONING ORMOC CITY INTO ELEVEN (11) REPRESENTATIVE DISTRICTS, DESIGNATING CHAIRMANSHIPS AND MEMBERSHIPS THEREOF AND A KAGAWAD-IN-CHARGE, RESPECTIVELY";

WHEREAS, one of the Councilors of this Sanggunian, Honorable Benjamin B. Lladoc, died last March 6, 1999 thereby causing a vacancy in the Chairmanship and Vice-Chairmanship of some standing committees of this Sanggunian, as well as the Kagawad-in-charge of the eight barangays assigned to him;

WHEREAS, for the good of the service and governance, it is imperative to fill-up the vacancies.

WHEREFORE, on motion of Councilor Mariano Y. Corro, Chairman, Committee on Internal Rules, jointly seconded by Councilor Eduardo P. Tan and Dennis Y. Capuyan; be it

RESOLVED, as it is hereby resolved, to pass a resolution partially reorganizing the chairmanship and membership of the standing committees of the Eight Sangguniang Panlungsod ng Ormoc, and the assignment of the Kagawad-In-Charge of the eight barangays, in view of the untimely demise

of Councilor Benjamin B. Lladoc, thereby amending accordingly Resolution No. 98-06, re: organization of standing committees, etc., in the following manner, to wit:

A. STEERING COMMITTEE - CHAIRMAN: Councilor Sotero M. Pepito; VICE-CHAIRMAN: Councilor Mariano Y. Corro; MEMBERS: All Councilors.

EDUCATION & CULTURAL DEVELOPMENT - CHAIRMAN: Councilor Nepomuceno P. Aparis I; VICE-CHAIRMAN: Councilor Alfredo F. Capahi; MEMBERS: Councilors Mariano Y. Corro, Sotero M. Pepito and Chiqui B. Labagala.

FINANCE COMMITTEE - CHAIRMAN: Councilor Alfredo F. Capahi; VICE-CHAIRMAN: Councilors Jose S. Serafica, MEMBERS: Jose C. Alfaro, Jr., Mariano Y. Corro, Sotero M. Pepito.

B. The Barangays which were previously assigned to Councilor Benjamin B. Lladoc, namely: Sto. Niño, Salvacion, Nasunogan, Cagbuhangin, Milagro, Luna, Dolores and Catmon, are now assigned to Councilor FERNANDO P. PARRILLA.
