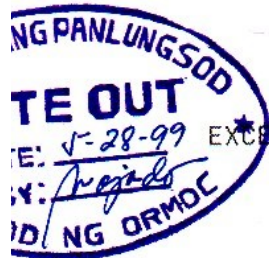
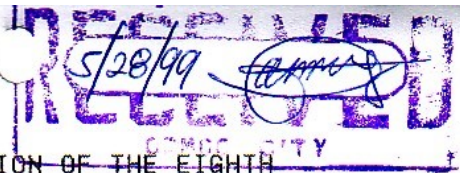
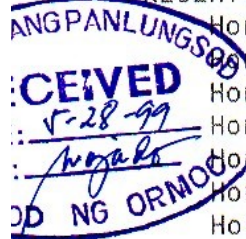

Councilors Sotero M. Pepito and Jose S. Serafica; be it


RESOLVED, to pass resolution APPROVING THE 1999 SUPPLEMENTAL

ADOPTED, May 27, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
