WHEREAS, this Sanggunian is in receipt of Barangay Resolution No. 8 1999 from Brgy. Can-adieng, this city, entitled: "A RESOLUTION REQUESTING ALL OFFICES CONCERN FOR THE RETENTION OF THE BRIDGE NAME TULAY DE PERSON" WHICH IS NOW NAMED MALBASAG BRIDGE";

WHEREAS, historically, said bridge was known as "Tulay de Perdon" residents of Brgy. Can-adieng and even by many Ormocanons;

WHEREAS, the matter of changing the names of streets and bridges is vested solely on the Sanggunian concern as provided for by Article 21 of Rule IV of the Implementing Rules and Regulations of the Local Government Code of 1991 which provides:

"Art. 21. Naming by the Sanggunians of Highly-Urbanized Cities and Independent Component Cities.

The Sanggunians of highly-urbanized cities and component cities whose charters prohibit their from voting for provincial elective officials, hereinafter referred to as independent cities may, in consultation with NHI, change the name of the following within their respective territorial jurisdiction:
