


A RESOLUTION AMENDING THE APPLICATION FOR DEVELOPMENT PERMIT OF SUBDIVISION PROJECT OF THE CITY GOVERNMENT OF ORMOC FROM P.D. 957 TO B.P. 220 INVOLVING LOTS 5362-A, 5362-B, 5362-C AND 5362-D-2 (LRC) PSD-236950 LOCATED AT BARANGAY SAN ISIDRO, ORMOC CITY, WITH A TOTAL AREA OF 40,674 SQUARE METERS, COVERED BY TCT NOS. 24619, 246120, 246121 AND 24676 CONTAINING 189 LOTS EXCLUDING PARKS AND PLAZA, COMMUNITY FACILITIES AND ROAD LOT.

PRESENTED, for consideration by this august Body is the following:

An Application for Amendment of Development Permit from P.D. 957 to B.P. 220 of Subdivision Project of the City Government of Ormoc involving lots 5362-A, 5362-B, 5362-C and 5362-D-2 (LRC) PSD-236950 located at Brgy. San Isidro, this city, with a total area of 40,674 square meters, covered by TCT Nos. 24619, 24620, 24621 and 24676 containing 189 lots excluding Parks and Plaza, community facilities and road lot;


