MILANY BERNAL, CITY THIS CITY, FOR CY 1997, AGAINST ENGINEER'S OFFICE, THIS CITY, FOR CY 1997, AGAINST CURRENT APPROPRIATION FOR CLOTHING ALLOWANCE OF THE SURRENT APP

PRESENTED for consideration by this august Body is a letter of Engr. Antonio Z. Padayao, City Engineer, addressed to the Sangguniang Panlungsod, this city, dated May 5, 1999, requesting that the 1997 Clothing Allowance of Ms. Milany Bernal be charged to current appropriation for clothing allowance of the said Office.

WHEREAS, the Human Resource Management Officer IV, through a Certification given on 06 May 1999 has stated that Ms. Milany Bernal is entitled to receive Clothing Allowance for the year 1997.

WHEREAS, the City Budget Officer, through 3rd Indorsement dated May 7, 1999, has requested that authority be granted to the City Accountant to charge above claim against current appropriation for Clothing Allowance of the City Engineer's Office in the amount of Two Thousand Pesos (\$2,000.00);
