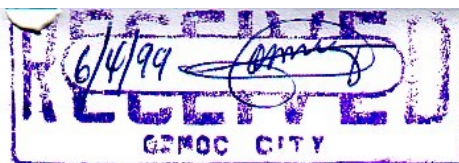
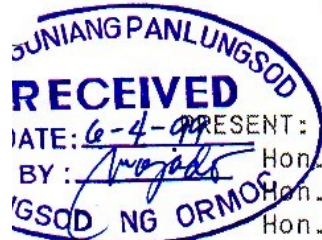

Councilors Sotero M. Pepito and Alfredo F. Capahi; be it


RESOLVED, to pass resolution APPROVING THE 1999 SUPPLEMENTAL BUDGET

ADOPTED, June 03, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
