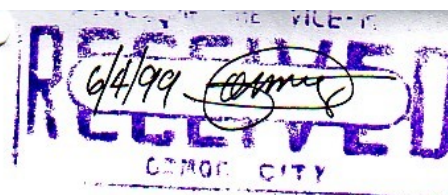
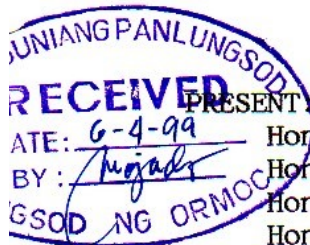

RESOLUTION NO. 99-88

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC THE REVISED MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF JUSTICE, REPRESENTED BY HONORABLE SERAFIN R. CUEVAS, SECRETARY, DEPARTMENT OF JUSTICE RELATIVE TO THE CONSTRUCTION OF A HALL OF JUSTICE.

WHEREAS, this Sanggunian is in receipt of a copy of the Memorandum of Agreement (MOA) between the Department of Justice and the City Government of Ormoc together with a letter dated 02 June 1999 from the Honorable City Mayor Eufrocino M.
