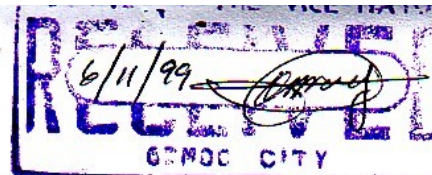
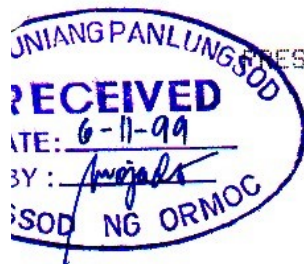

Dennis Y. Capuyan, Mariano Y. Corro & Fernando P. Parrilla; be it


RESOLVED, to pass a resolution APPROVING THE 1999 SUPPLEMENTAL

ADOPTED, June 10, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
