

RESOLUTION NO. 99-91

AUTHORIZING THE HONORABLE MAYOR CITY A RESOLUTION RELEASE CODILLA SR., TO EUFROCING M. OF THE HOMELOTS AT THE RAMON ABOITIZ (RAFI) RESETTLEMENT SITE AT BRGY. TITLEYOWNERSHIP FOUNDATION. INC. (RAFI) RESETTLEMENT SITE AT BRGY. TAMBULILID. THIS CITY, TO THEIR QUALIFIED OCCUPANTS AS DETERMINED AND RECOMMENDED BY CITY SOCIAL WELFARE AND DEVELOPMENT OFFICER, MRS. MARIETTA S. LEGASPI AND DULY NOTED BY PUNCHE BARANGAY CRISPULO T. ESPINA, SUBJECT TO THE TERMS AND CONDITIONS HEREIN STATED.

WHEREAS, the City Government of Ormoc has been releasing the ownership/title of the homelots to their qualified occupants at the different resettlement sites established after the calamity flash-flood brought about by typhoon "URING" on November 5, 1991, to provide shelter to the flood victims;

WHEREAS, the City Government of Ormoc is of the sincere belief that there can be a faster and better development of these resettlement sites the ownership/title of these homelots shall be released to the qualified occupants thereof;

WHEREAS, one of these resettlement sites has been denominated as Ramon Aboitiz Foundation, Inc.;

Sangguniang Pambarangay of Tambulilid WHEREAS, the Resolution No. 31, Series of 1997, requesting the City Government of Ormoc, the release of the title/ownership of the homelots of the different resettlement sites in their barangay;

WHEREAS, City Social Welfare and Development Officer, Mrs. Marietta S. Legaspi, favorably recommended the release of lot titles to Four Hundred Thirty-Five (435) qualified allocatees per letter dated June 4, 1999, and which recommendation was duly noted by Punong Barangay Crispulo T. Espina, copy of which is hereto attached for ready reference;

FOREGOING PREMISES CONSIDERED, on motion of Councilor Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by Councilors Sotero M. Pepito, Dennis Y. Capuyan and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution authorizing the Honorable City Mayor Eufrocino M. Codilla, Sr., to release the title/ownership of the homelots at the Ramon Aboitiz Foundation, Inc. resettlement site at Brgy. Tambulilid, this city, to their qualified occupants as determined and recommended by City Social Welfare and Development Officer, Mrs. Marietta S. Legaspi and duly noted by Punong Barangay Crispulo T. Espina, subject to the terms and conditions herein stated, to wit:

- 1. That title/ownership of the homelots will be released to qualified occupants sans cost to them;
- That the cost of the individual titling of the homelots will be borne solely by the beneficiaries thereof;
- 3. That these homelots shall not be transferred or assigned to any person, natural or juridical, within a period of twenty-five (25) years from the date of the individual titling thereof, except by hereditary succession, and any transfer or assignment in violation hereof shall be null and void:
- 4. That the lawful owner may mortgage the homelots to any financial and/or home-financing institutions, to secure a loan for the construction/repair/remodeling of the house in said lot, in which case the said owner shall notify in writing the City Mayor of Ormoc;
- 5. That condition three (3) and four (4) hereof, shall be incorporated in the document of transfer from the City Government of Ormoc to the qualified occupants/beneficiaries, and further annotated in the Certificates of Title that may be issued to the qualified occupants/beneficiaries.

ADOPTED, 17 June 1999.

Legaspi, the Punong Barangay of Tambulilid, Honorable Crispulo T. Espina, Sr., City Treasurer, City Assessor, Mrs. Cristeta B. Tugonon, and all others concerned offices.
