AUTHORIZING THE CITY ACCOUNTANT TO CHARGE A RESOLUTION AMOUNT OF THREE THOUSAND SIX HUNDRED EIGHTY-ONE 22/100 (₱3,681.22) AGAINST CURRENT APPROPRIATION FOR PROVISION FOR PRIOR-YEAR'S OBLIGATION THE UNPAID ISLACOM TELEPHONE BILLS OF THE OFFICE OF THE CITY BUDGET OFFICER (RESIDENCE) FOR THE PERIOD JULY, AUGUST, CCTOBER & NOVEMBER 1998.

WHEREAS, this Sanggunian is in receipt of a communication dated 20 1999 from Mrs. Elena S. Aviles, City Budget Officer, addressed the Honorable Members of the Sangguniang Panlungsod, thru the Honorable Celso P. Adolfo, Vice Mayor & Presiding Officer, requesting authority to charge against current appropriation for Provision for Prior-Year's Obligation the amount of THREE THOUSAND SIX HUNDRED EIGHTY-ONE PESOS & 22/100 ONLY (₱3,681.22) representing the unpaid ISLACOM telephone bills of the Office of the City Budget Officer (Residence) for the period July, August, October & November 1998;

WHEREAS, the City Accountant thru 3rd Indorsement dated 9 June 1999 confirmed the unpaid ISLACOM Telephone bills of the City Budget Office for 1999 in the amount of THREE THOUSAND SIX HUNDRED EIGHTY-ONE PESOS & 22/100 (\$23,681.22);

WHEREAS, the ICO - City Treasurer through 5th Indorsement dated 14 1999 has stated that fund is available to be charged against current appropriation for Provision for Prior-Year's Obligation subject however, to accounting and auditing rules and regulations;;

NOW, THEREFORE, on motion of Councilor Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Councilor Jose S. Serafica; be it
