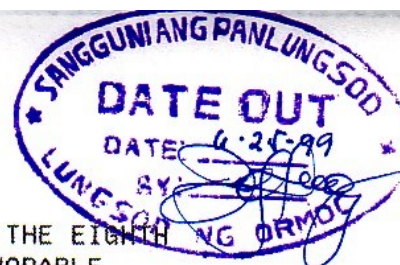
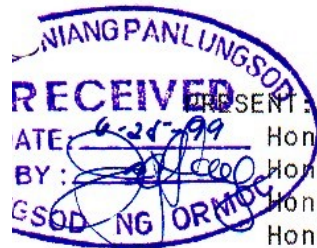


ADOPTED, June 24, 1999.


