RESOLUTION NO. 99-98

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFRODINO M. CODILLA, SR., TO ISSUE ADDITIONAL EIGHTY (80) POLICE NUMBERS FOR TRICYCLES TO OPERATE IN THE BARANGAYS OF VALENCIA, SAN JOSE, SABANG BAO VIA LABRADOR (BALION) TO LILO-AN, AND MATICA-A, THIS CITY EXCEPT ALONG NATIONAL HIGHWAYS.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor dated 03 June 1999 addressed the Honorable Members, 8th Sangguniang Panlungsod, thru Hon. Celso P. Adolfo, Vice Mayor & Presiding Officer, the full text of which is hereunder cited as follows:

Gentlemen:

The operations of "Habal-Habal" (motorcycle without sidecar used transport passengers) is nowadays rampant especially in the barangays of Valencia, San Jose, Sabang Bao and Matica-a. This type of transportation is known to be risky as evidenced by several accidents involving it.

As a way of curtailing therefore the operations of said transportation, I desire that these motorcycles be converted to tricycle for the good of our commuters. With motorized tricycle occurrence of accidents will be minimized and their operations will be legitimized.

In view of the foregoing, may I respectfully request this august Body for additional Eighty (80) Tricycle Police Numbers to be issued to interested and qualified operators.
