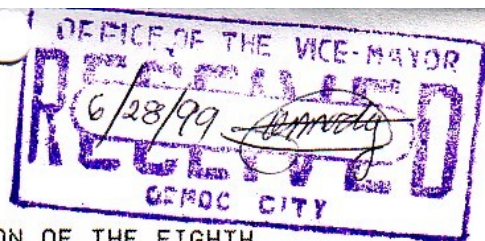
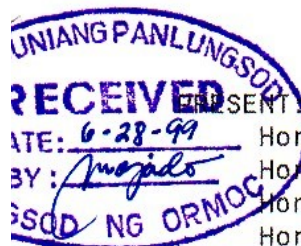

esteemed former OIC - City Mayor of Ormoc ATTY. GUILLERMO TOMADA
PARRILLA who succumbed in the morning of June 18, 1999;

WHEREAS, the late Atty. Guillermo Tomada Parrilla, a resident of
Ormoc City, a hardworking man, had dedicated the best years of his life
to public service, helped bring Ormoc to its present status, a
financially stable, peaceful and beautiful city;

WHEREAS, reckoning back to his service as a public official, which
he has served for nineteen (19) years, he was appointed as Municipal
Councilor of Ormoc (1945 - 1947), Elected City Councilor for sixteen

December 1987 to January 1988. The late Atty. Guillermo T. Parrilla has
also served as Registrar, Register of Deeds of Ormoc City for ten (10)
years from 1967 to 1977;

father and an accommodating kin, who, for a good number of years has
dedicated his life in government service;

WHEREAS, "IMO" as he was fondly called was awarded Honorary Life Membership in the Knights of Columbus, former President of "Adoracion Nocturna" and a former member of Rotary International Club and the founder of Western Leyte College and Sto. Niño College, this city;


