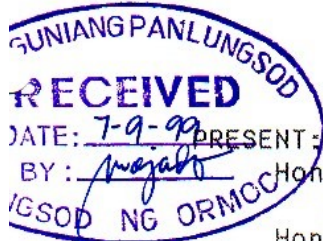

Alfredo F. Capahi; be it


RESOLVED, to pass resolution APPROVING THE 1999 SUPPLEMENTAL BUDGET
