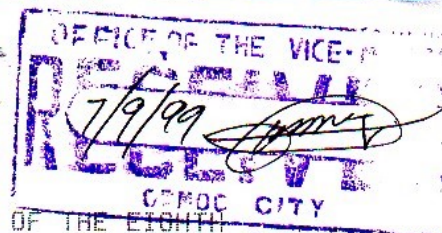
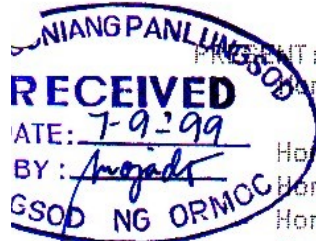

RESOLUTION NO. 99-106

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE
MA. VICTORIA L. LOCSIN, REPRESENTATIVE OF THE FOURTH
DISTRICT OF LEYTE, TO SPONSOR A BILL IN CONGRESS
DECLARING JUNE 29 OF EVERY YEAR A SPECIAL NON-WORKING
PUBLIC HOLIDAY IN ORMOC CITY TO BE KNOWN AS "ORMOC CITY
DAY".

WHEREAS, the 29th day of June of every year is the feast day of
Sts. Peter and Paul, the patron saints of Ormoc City;

WHEREAS, the feast day of Sts. Peter and Paul is a very special
occasion to all Ormocanons as the city's sons and daughters come back to
their birthplace and savor the comforting feeling of being with their
loved ones;

WHEREAS, employees, both in the Private and Government Sectors, in
Ormoc City would like to commemorate, and join in the celebration, of
the feast of their beloved patron saints, Peter and Paul; without their
being considered absent from work;

WHEREAS, the feast day of other cities, particularly Tacloban City
and Oroquieta City, have been declared as Special Non-working Holiday
through the enactment of laws, known as Republic Act No. 7676, "AN ACT
DECLARING JUNE THIRTY OF EVERY YEAR A SPECIAL NONWORKING PUBLIC HOLIDAY
IN TACLOBAN CITY, PROVINCE OF LEYTE, TO BE KNOWN AS 'TACLOBAN DAY'",
and Republic Act No. 7677, "AN ACT DECLARING OCTOBER SIXTEEN OF EVERY
YEAR AS A SPECIAL NONWORKING HOLIDAY IN THE CITY OF OROQUIETA TO BE
KNOWN AS OROQUIETA CITY DAY", respectively;

WHEREFORE, premises considered, on motion of Councilor Mariano Y. Corro, jointly seconded by Councilors Chiqui B. Labagala and Dennis Y. Capuyan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE HONORABLE MA. VICTORIA L. LOCSIN, REPRESENTATIVE OF THE FOURTH DISTRICT OF LEYTE, TO SPONSOR A BILL IN CONGRESS DECLARING JUNE 29 OF EVERY YEAR A SPECIAL NON-WORKING PUBLIC HOLIDAY IN ORMOC CITY TO BE KNOWN AS "ORMOC CITY DAY";


