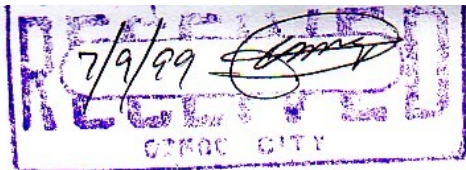

RESOLUTION NO. 99-103

A RESOLUTION INTERPOSING NO OBJECTION AND GRANTING SOCIAL
ACCEPTABILITY TO THE POULTRY OF CORAZON ANOOS IN
CONNECTION WITH HER APPLICATION FOR ENVIRONMENTAL
CLEARANCE CERTIFICATE (ECC).

WHEREAS, this Sanggunian is in receipt of Resolution No. 99-13 of
Barangay Lilo-an, this city, entitled: "A RESOLUTION INTERPOSING NO
OBJECTION TO THE PROPOSED OPERATION OF EXISTING POULTRY HOUSE OWNED BY
MRS. CORAZON ANOOS, AT SITIO BAHAY LILOAN OROC (SIC) CITY, AND
REQUESTING APPROVAL FROM THE SANGGUNIANG PANLUNGSOD OF ORMOC, IN
CONNECTION WITH HER APPLICATION FOR ISSUANCE OF ENVIRONMENTAL COMPLIANCE
CERTIFICATE (ECC);

WHEREAS, Mrs. Corazon Anoos has applied for the issuance of an
Environmental Compliance Certificate with the Department of Environment
and Natural Resources (DENR) in connection with the operation of a
poultry house located at Sitio Bahay, Barangay Lilo-an, this city;

WHEREAS, upon proper consultation with the residents of Barangay
Lilo-an, this city, same is socially accepted as manifested by the
Brgy. Council through Barangay Resolution No. 99-13 dated June 1, 1999
provided that there should be a proper sanitation and maintenance of
waste disposal coming from the operation;

Chairman, Committee on Natural Resources and Environmental Control,
jointly seconded by Councilors Claudio P. Larrazabal and Alfredo F.
