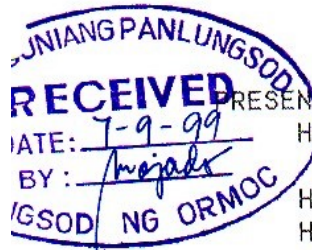

A RESOLUTION TRANSFERRING THE REGULAR SESSION OF THE  
EIGHTH SANGGUNIANG PANLUNGSOD NG ORMOC FROM JULY 15,  
1999 TO JULY 14, 1999 CONSIDERING THAT FIVE (5) CITY  
COUNCILORS WILL BE OUT OF TOWN ON OFFICIAL BUSINESS,  
TWO (2) OF WHICH TO TACLOBAN CITY, ANOTHER TWO (2) TO  
TAGBILARAN CITY AND ONE (1) COUNCILOR TO COQUITLAM,  
CANADA.

WHEREAS, per Internal Rules and Regulations of the Sangguniang  
Panlungsod ng Ormoc, Regular Sessions thereof are set up on every  
Thursday of every week;

WHEREAS, next Thursday, July 15, 1999 is the scheduled date for the  
five (5) City Councilors to be out of town on official business, City  
Councilors Nepomuceno P. Aparis I and Eduardo P. Tan will be attending  
the Philippine Councilor's League Meeting in Tacloban City, City  
Councilors Dennis Y. Capuyan and Alfredo F. Capahi will be attending the
