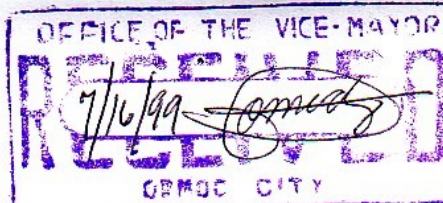
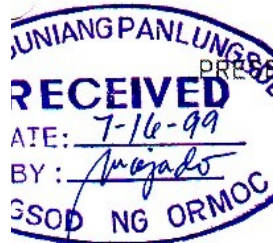

RESOLUTION NO. 99-110

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 14, SERIES
OF 1999 OF BARANGAY MATICA-A, ORMOC CITY, ENTITLED: "AN
ORDINANCE IMPLEMENTING CHARGES FOR DRYING PALAY IN OUR
SOLAR DRYER AND STORAGE FEE IN OUR BARANGAY STAGE".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 14, series
of 1999 of the Barangay Council of Matica-a, this city, entitled: "AN
ORDINANCE IMPLEMENTING CHARGES FOR DRYING PALAY IN OUR SOLAR DRYER AND
STORAGE FEE IN OUR BARANGAY STAGE";
