

WNERCAS, this Sanggunian is in receipt of Ordinance No. 14, series 1999 of the Bacangay Council of Matica-a, this city, entitled: IMPLEMENTING CHARGES FOR DRYING PALAY IN OUR SOLAR DRYER ORDINANCE AND STORAGE FEE IN OUR BARANGAY STAGE";
