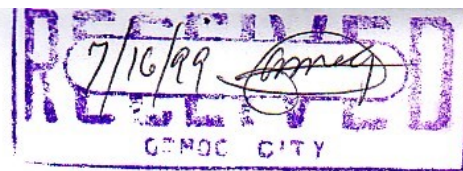

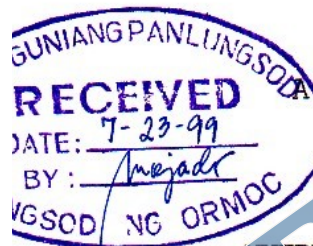

RESOLUTION OF CONDOLENCE TO THE BEREAVED FAMILY OF THE
LATE HONORABLE MARCELO B. FERNAN, FORMER CHIEF JUSTICE
OF THE SUPREME COURT AND SENATE PRESIDENT, PHILIPPINE
SENATE.

WHEREAS, this august Body together with the City Officials and the people of Ormoc bear the grief with the passing away of a statesman and patriot, HONORABLE MARCELO BRIONES FERNAN, who succumbed in the afternoon of July 11, 1999;

WHEREAS, the late HONORABLE MARCELO B. FERNAN, a resident of Cebu City, is the only Filipino to have headed two powerful government branches, the Supreme Court of the Philippines and the Philippine Senate. "Celing" as he was fondly called, is a man of integrity, and always set the example of diligence, competence and fidelity to duty;

WHEREAS, to mention a few of his services as a public official, he was a delegate to the 1971 Constitutional Convention and of the Batasang Pambansa in 1982, appointed Associate Justice 1986 and became the 19th Chief Justice of the Supreme Court (1988 - 1991), and President of the Senate (1998 - 1999);

WHEREAS, the HONORABLE MEMBERS of the EIGHTH SANGGUNIANG PANLUNGSOD ng ORMOC, its City Officials and the Ormocanons, greatly share the intense pain and sorrow with his wife MRS. ELOISA NOLASCO FERNAN and Children Maria Eloisa, Maria Margarita, Maria Aurora, Maria Emiliana, Marcelo Jr., Maria Milagros, Maria Ramona, Michael and Manuel as well as the anguish and despair with the passing away of a model family man and an exemplary public servant who for a good number of years has dedicated the best years of his life in government service;



RESOLVED, FINALLY, to affix our signatures in this Resolution of Condolence, and be it;


