

RESOLUTION NO. 99-120

A RESOLUTION APPROVING ORDINANCE NO. 01-5-99 OF THE SANGGUNIANG BARANGA' OF BARANGAY MANLILINAD, THIS CITY, ENTITY TO A "AN ORDINANCE IMPOSING PENALTIES TO OWNERS OF VERICLES AND ASTRAYED ANIMALS AND FLAGOR CORN, DANAGE TO DRNAMENTAL PLANTS, CROPS, RICEFIELDS, CORN, DANAGE TO DRNAMENTAL PLANTS, CROPS, TRANH RECEPTACLES, FENCES AND OTHER CLEAN AND GREEN DEVICES WITHIN THE JURISDICTION OF BARANGAY MANLILINAO, ".YTIZ SOMAO

WHEREAS, this Sanggunian is in receipt of Ordinance No. 01-S-99 of the Baranga: Council of Manlilinao, this city, entitled: "AN ORDINANCE IMPOSING PENALTIES TO OWNERS OF VEHICLES AND ASTRAYED ANIMALS AND PERSON THAT CAUSE DAMAGE TO ORNAMENTAL PLANTS, CROPS, RICEFIELDS, CORN, TRASH RECEPTACLES, FENCES AND OTHER CLEAN AND GREEN DEVICES WITHIN THE JURISDICTION OF BARANGAY MANLILINAO, ORMOC CITY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether the said ordinance is consistent with law and city X X X ordinances; (Sec. 57, 1991, LGC)

WHEREAS, it is the observation of this august Body, through the representation of the Honorable Chairman, Committee on Laws Ordinances that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Brgy. Manlilinao, to legislate;

WHEREFORE, foregoing premises considered, on motion of Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, duly seconded by Councilor Chiqui B. Labagala; be it

RESOLVED, to pass a resolution APPROVING ORDINANCE NO. 01-S-99 OF THE SANGGUNIANG BARANGAY OF BARANGAY MANLILINAO, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING PENALTIES TO OWNERS OF VEHICLES AND ASTRAYED ANIMALS AND PERSON THAT CAUSE DAMAGE TO ORNAMENTAL PLANTS, CROPS, RICEFIELDS, CORN, TRASH RECEPTACLES, FENCES AND OTHER CLEAN AND GREEN DEVICES WITHIN THE JURISDICTION OF BARANGAY MANLILINAO, ORMOC CITY;"
