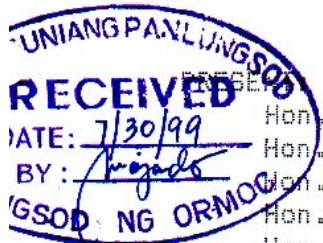

RESOLUTION NO. 99-121

A RESOLUTION APPROVING ORDINANCE NO. 02-S-99 OF THE
SANGGUNIANG BARANGAY OF BARANGAY MANLILINAO, THIS CITY,
ENTITLED: "AN ORDINANCE IMPOSING THE INCREASE OF
BARANGAY CLEARANCE FEE ON BUSINESS ESTABLISHMENT,
EMPLOYMENT, TRAVEL ABROAD, MARRIAGES, ENROLLMENT AND
CHARACTER VERIFICATION IN THE BARANGAY."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 02-S-99 of
the Barangay Council of Manlilinao, this city, entitled: "AN ORDINANCE
IMPOSING THE INCREASE OF BARANGAY CLEARANCE FEE ON BUSINESS
ESTABLISHMENT, EMPLOYMENT, TRAVEL ABROAD, MARRIAGES, ENROLLMENT AND
CHARACTER VERIFICATION IN THE BARANGAY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City), is by law, granted the Power of
